14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ As summarized in the attachment, the issuer paid distributions to shareholders in excess of earnings and profits, resulting in a return of capital to shareholders. Return of capital in excess of a shareholder's tax cost basis may result in capital gains.
